Dear colleagues,

On Friday the 4 December, 2020 I will be leaving the comfort of my own home and sleeping out in Galway's bitterly cold winter weather with just a sleeping bag as part of COPE Galway's 2020 Business Sleep Out. The COPE Galway Business Sleep Out is an annual event to raise awareness for the issue of homelessness and raise funds to support COPE Galway's Homeless Services.

The effects of COVID-19 have been unexpected and far-reaching and everyone has undoubtedly had a very different experience over the course of the last 9 months or so. For those that rely on the support provided by COPE Galway, COVID-19 has been devastating and it has caused significant levels uncertainty and distress to people living without a home. Self-isolating when you experience symptoms of COVID-19 is a difficult task for anybody to manage and this is particularly so when you have no home to go to.

In 2019, COPE Galway worked with 1,189 adults and 433 children affected by homelessness. This work helped find and retain long-term housing and reduce the level of homelessness within our community. COVID-19 has exacerbated problems associated with homelessness and COPE Galway has reconfigured its homeless services to respond to this crisis by creating extra emergency capacity.
