Business Recovery Survey

From the early stages of the pandemic, the Council of the Law Society resolved to support member firms through the immediate crisis and into the next phase: business recovery. As part of this strategy, the Business Recovery research was conducted by Crowe during March to May of 2021 involving an online survey and interviews. The resulting report, published recently, explores solicitors' experiences of the business impact of the Covid-19 pandemic. It aims to understand the type of supports required from the Society and Government into the future. Download the report.

Afghan Crisis

The Law Society is a founding member of the Irish Justice Community Response to the Afghan Crisis, a coalition of the Bar of Ireland, Association of Judges in Ireland, International Association of Women Judges, and Irish Rule of Law International.

This collaborative effort has been established to express solidarity with, and support for, Afghan judges, who have faced enormous challenges in recent months. The Irish State has now secured safe passage and protection for 11 Afghan female judges and their families arising from the dangers they would otherwise face by remaining in Afghanistan. Their arrival in Ireland is imminent.

Justice Community Fund appeal

A special fund – the Justice Community Fund – has been set up to assist with providing support to the judges and their families. Donations to the fund will help these families to start afresh in Ireland, and contribute to the cost of food, accommodation, as well as health and social care.
